Hearts Alive Village Las Vegas as known for here forth as HAVLV, a Nevada non-profit corporation and the undersign (Adopter) in consideration of mutual promises in this agreement and other good and valuable considerations, intending to be legally bound by this agreement , agree to the following:

- CARE OF THE ANIMAL:** Adopter understand that the animal he/she is adopting is an **indoor** pet, and agrees not to let the pet outside without being supervised on a harness/leash. Adopter is to allow full access to his/her home providing the animal with fresh water, wholesome food, adequate exercise, and affection. Adopter agrees to not chain or tie up the animal or to allow the animal to ride uncaged in a motorized vehicle. Adopter also agrees to comply with local and states statutes and ordinances.
- RETURN POLICY:** Adopter agrees that he/she is unable to care for the animal for it entire lifetime, he/she will contact HAVLV and return it to a location as specified by HAVLV Adopter understands that he/she will be responsible for the care of the animal until he/she has delivered the animal into the proper hands of HAVLV. Out of state adoptions agree to cover the full financial obligation for return of the animal to HAVLV. Adopter understands no adoption fees will be refunded.
- ADOPTION DONATION:** Adopter agrees to pay an adoption donation of \$_____ for the animal to help defray HAVLV expense for food, sheltering, and veterinary care. Additional donations are welcomed.
- IDENTIFICATION/LICENSE:** The animal is micro-chipped for identification purposes. The Adopter agrees to obtain the proper municipal licenses as required by law.
- VETERINARY CARE:** Adopter agrees to provide the animal with necessary vaccinations as advised by his/her veterinarian. Adopter agrees to obtain immediate veterinary care should the animal become sick or injured and to take full financial responsibility for such veterinary expenses.
- NO REPRESENTATIONS:** Adopter understands that HAVLV does not guarantees the health, temperament, or training of the above animal, and the Adopter hereby holds HAVLV , its agents and employees , and

volunteers harmless from any claims, cause of action, or liability for any injury or damages to person or property in connection with adoption or ownership of the animal. If a health problem does develop, Adopter agrees to notify HAVLV to discuss the matter.

- 7. CHANGE OF ADDRESS:** In the event of the Adopter moves he/she agrees to notify HAVLV with the change of address information so that HAVLV records can be updated.
- 8. PET GOES MISSING:** In the event the pet accidentally escapes from its home, the Adopter is to immediately notify HAVLV to advise of the situation. HAVLV will utilize its resources to assist in the quick and safe return of the pet to the Adopter.
- 9. HAVLV LIFETIME COMMITMENT:**
 - a.** HAVLV will notify Adopter by certified mail, return receipt requested, of the reclamation and ask that the animal be returned. The notice will clearly state the circumstances under which HAVLV is acting and state a date when the Adopter may meet the agents of HAVLV to discuss the situation.
 - b.** After 7 days of posting this notice, if the Adopter has not notified HAVLV, or has not accepted the notice, legal action will be taken by HAVLV to retrieve the animal.
 - c.** If the animal is in an extreme circumstance as to endanger its life HAVLV may call animal control in the Adopters locality to recover the animal on HAVLV's behalf.
 - d.** In the event of the pet being picked up by animal control and detained at the shelter/pound due to Adopter's neglect of allowing the pet roam free and to be at-large. The adopter automatically relinquishes all rights of ownership of the pet to HAVLV.
 - e.** In the event either of the foregoing situations occur, or if for any reason the animal is returned to HAVLV, Adopter may request a meeting to discuss the matter within ten days after the animal is reclaimed.
 - f.** Any decision by HAVLV is final as to whether the animal shall be returned to the Adopter.

THIS AGREEMENT is the entire agreement between HAVLV and Adopter and supersedes any prior understanding between the parties with respect to the subject matter in this agreement. No modification of this agreement will be valid unless in writing and duly signed by HAVLV and Adopter. This agreement is binding upon heirs, assigns, successor, personal representatives, and executors of both parties.
